- Approved the Minutes of the City Council Regular Meeting of June 20, 2022 as amended by Councilmember Hernandez.
- 3. Received and filed the Register of Disbursements for the period of June 14, 2022 through June 27, 2022.
- Adopted an Ordinance entitled, "An Ordinance of the City Council of the City of Port Hueneme, California, amending Article VIII, Building Regulations, of the Port Hueneme Municipal Code which adds Chapter 9, to implement standards pertaining to an expedited, streamlined permitting process for electrical vehicle charging stations".
- 5. Approved the Second Amendment to the National Pollutant Discharge Elimination System (NPDES) Implementation Agreement for the Ventura County Stormwater Quality Management Program between the County of Ventura, the Ventura County Watershed Protection District (VCWPD); and the Cities of Camarillo, Fillmore, Moorpark, Ojai, Oxnard, Port Hueneme, San Buenaventura, Santa Paula, Simi Valley, and Thousand Oaks.
- Allocated \$5,500 towards the cost of a Ventura County Countywide Farmworker Housing Study, funding a countywide survey of farmworkers, employers, and housing providers to further define housing conditions, needs and barrieres to farmworker housing.
- Adopted an Ordinance entitled, "An Ordinance of the City Council of the City of Port Hueneme, Calfiornia, Adopting a Military Equipment Use Policy Pursuant to Government Code Section 7070 ET SEQ. (AB 481)".
- Authorized the sole source purchase of antiscalant, per Municipal Code Section 2564(b), from King Lee Technologies in the amount of \$52,750, for use at the PHWA Water Treatment Plant (Brackish Water Reclamation Demonstration Facility)

6. Letter of Opposition to Ventura County Board of Supervisors Regarding Microenterprise Home Kitchen Operations Program (MEHKO)

T. Stewart, Community Development Director

Recommendation: Authorize the City Manager to electronically send a letter to the County of Ventura Board of Supervisors in opposition of the County's Microenterprise Home Kitchen Operations Program (MEHKO).

Councilmember Gama asked clarifying questions then recused himself out of an abundance of caution due to a possible conflict of interest with operating a cottage bakery. Councilmember Gama left the meeting at 6:51 p.m.

Council discussion ensued and staff responded to clarifying questions from Council.

Award of Contract for Exterior Painting at the Orvene S. Carpenter Community Center and Library

Housing & Facilities Director Gabby Basua and Community Development Director Tony Stewart presented the report.

Community Development Director Tony Stewart responded to Mayor Rollins inquiry regarding the color scheme. Council discussion ensued.

There were no public comments.

ROLL CALL VOTE

A motion was made by Councilmember Hernandez, seconded by Councilmember Perez, to award a contract to Color New Co. for exterior painting at the Orvene S. Carpenter Community Center and Library, and authorize the City Manager to execute a contract subject to review and approval of the City Attorney.

Motion failed as follows:

NOES: Gama, Martinez, Rollins; ABSENT: None; ABSTAIN: None

Discussion ensued amongst the Councilmembers. City Manager Conners offered an alternative solution to approve the contract subject to Council review and approval of the color scheme/palette.

Housing & Facilities Director Gabby Basua answered questions from Council. In response to an inquiry from Housing & Facilities Director Basua, City Attorney Spaulding clarified that a motion to reconsider can be made, however, it would need to be made by a Councilmember who voted no.

Mayor Rollins stated he would make a motion to approve the contract pursuant to finding out what the color would be, but no formal motion was made.

A motion was made by Mayor Pro Tem Martinez to move this item to the next City Council meeting in order to see the color scheme before approving. Motion failed for lack of second.

Discussion ensued amongst Council and staff

A motion was made by Mayor Rollins to award a contract to Color New Co. for exterior painting at the Orvene S. Carpenter Community Center and Library subject to review and approval of the color scheme. Motion failed for lack of second.

ROLL CALL VOTE

A motion was made by Mayor Rollins, seconded by Mayor Pro Tem Martinez, to reconsider staff recommendation to approve the contract to Color New Co. for exterior painting at the Orvene S. Carpenter Community Center and Library, and authorize the City Manager to execute a contract subject to review and approval of the City Attorney; with the amendment that the color palette is subject to review and approval.

Motion failed - Roll Call vote was interrupted due to confusion of the motion: AYES: Rollins, Martinez.

Mayor Rollins restated his motion for clarification to approve the contract to Color New Co. for exterior painting at the Orvene S. Carpenter Community Center and Library, and authorize the City Manager to execute a contract subject to review and approval of the City Attorney; with the amendment that the color palette is subject to review and approval.

Discussion ensued amongst Council and staff.

A motion was made by Councilmember Perez to approve the contract to Color New Co. for exterior painting at the Orvene S. Carpenter Community Center and Library, and that Council go into the office to view the color palette. Motion failed due to lack of second.

After considerable discussion, Housing & Facilities Director Gabby Basua presented the selected colors to Council.
