1. [Ratification of Labor Contract with Service Employees International Union \(SEIU\) Local 721](#)

Deputy City Manager Charles Peretz presented the report and answered questions from Council. There were no public comments.

A motion was made by Councilmember Gama, seconded by Councilmember Perez, to ratify the three-year Comprehensive Memorandum of Agreement by adopting Resolution No. 4420 approving a Memorandum of Agreement with the City of Port Hueneme General

Unit Employees represented by the Service Employees International Union (SEIU), Local 721 with a contract period of July 1, 2022 through June 30, 2025.

Before the vote was taken, Deputy City Manager Charles Peretz stated for the record, that a correction was made to the attachment of the Resolution that Council will be adopting which had incorrect year information in two locations which stated 2012 and should have stated 2022.
